REGULAR MEETING OF THE BOARD OF EDUCATION - MINUTES

March 1, 2011

The Board of Education of the San Leandro Unified School District met in regular session on March 11, 2011, in the San Leandro City Council Chambers, 835 East 14th Street, San Leandro, California.

PUBLIC COMMENTS REGARDING CLOSED SESSION AGENDA

There were no public comments concerning items on the closed session agenda.

CLOSED SESSION

At 6:04 p.m., the Board went into closed session for Student Expulsions, Public Employee Discipline/Dismissal/Release/Hiring, Conference with Labor Negotiator, and Conference with Legal Counsel – Anticipated Litigation – Significant exposure to litigation – 1 case, pursuant to Education Code Sections 35146 and 48918 (c), and Government Code Sections 54957, 54957.6, 54956.9. The closed session was adjourned at 7:02 p.m.

The Board returned to open session at 7:05 p.m. with the Pledge of Allegiance to the Flag. President Mack-Rose said the Board had been in closed session where the following action was taken:

 On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board took action to release non-reelect temporary or probationary certificated employees pursuant to Education Code section 44951 and 44929.21 by adoption of Resolution #11-13. This resolution was approved by a roll call vote of 7-0.

APPROVAL OF AGENDA

On a motion made by Trustee Sullivan and seconded by Trustee Carey, the Board approved the agenda for the regular meeting of March 1, 2011, by a 7-0 vote.

PRESENTATIONS

* K to College Acknowledgement

The Board of Education and Superintendent recognized the *K to College* School Supply Initiative Program who provided 3,998 free school supply kits for our K-12 San Leandro students in the fall, the majority of whom are low income. San Leandro Unified School District was fortunate to be a recipient of the *K to College* School Supply Initiative (SSI) whose goal is to provide students with the beginning of the year materials necessary to achieve in school as their other peers do. In addition, this past month, *K to College* also provided every K-3 student in the District a free dental kit. The total value of the school supply and dental kits was \$302,950. Executive Director Bonito Delgado-Olson was present to accept a Certificate of Commendation on behalf of *K to College*. The school supply distribution list is as follows:

* Keep the Music Rockin' Foundation

T.W. "Rick" Richards, CEO of Keep Music Rockin' Foundation, provided an update on the Foundation's current efforts on behalf of music support in our San Leandro schools. In keeping with their mission to promote awareness of the importance of music in our schools and to raise funds to enhance and enrich the learning experiences of students, the presentation included its fundraising efforts and areas of support for our music students. Presentation highlights included:

- The Foundation is comprised of a nine-member Board of Directors who share a true love for music whether it is performing, teaching music (vocal & instrumental), song writing, etc.
- The Advisory Board members provide an expertise in or represent a variety of areas and components with business & community members, the music industry, vocal, instrumental, music production, instruction, and entertainment, etc.
- Fundraising, grants, sponsors, and donations help restore programs, purchase new musical equipment supplies, etc. for our students which will help and enhance their learning experiences throughout the District
- The Foundation's annual fundraising efforts currently include Holidays with Lenny Williams Benefit Concert and Lenny Williams Golf Classic
- San Leandro High School Jazz Ensemble, Karoling Kids, comprised of ten 4th & 5th grade students from each elementary school, and the San Leandro High School Concert Choir perform at the Lenny Williams benefit concerts
- The Learning from the Masters Program was started in 2009/2010. The program creates partnerships between the Foundation and professional musical artists from various musical backgrounds and disciplines and offers clinics (after school and early evening hours) ranging from specific instruments (brass, guitar, keyboard, percussion) to vocal coaching to music improvisation.

Student Board member Engler commented that he has attended many of the concerts and has participated in some of the clinics. He encouraged the Board to visit a clinic, which he found to be interesting and engaging.

The Board thanked Mr. Richards for the presentation and for the Foundation's support to our students and to "Keep the Music Rockin' in our schools."

* Layoff Process

John Thompson, Senior Director II, Human Resources, provided a presentation on the layoff process for certificated employees. This presentation included a review of the timeline, applicable education code(s) and layoff procedures. Key points included:

- Board action taken during the 2009-10 school year to eliminate services for the 2011-12 school year requires that the lay off process be completed during the current 2010-2011 school year
- Will not have budget answers prior to June elections
- Need to prepare for potential non-passage of ballot measure in June
- If ballot measure passes, the District could be in a position to rehire many affected employees
- Layoff Procedures and Timeline:
 - 1. February:

Board adopted Skipping and Tie Breaking Resolutions

2. March:

Particular Kinds of Service Resolution (March 1) Release of temporary employees Resolution (March 1) Probationary Non-reelection Resolution (March 8) Administrative Reassignment Resolution (March 8)

- 3. Prior to March 15:
 All released employees must be notified
- 4. March-May:

Laid off teachers are entitled to Hearings and Negotiations

5. By May 15:

Layoff notices are either rescinded or become final

6. Laid off employees are placed on rehire list

In response to Trustee Mack-Rose, Mr. Thompson explained that due to a retirement that occurred, the Independent Study position slated to be cut was removed the list. He also explained that the principals would be hand delivering the letters to their respective employees and would express the District's concern and regret for this unfortunate, but necessary part of the process.

2.2-C <u>Job Description for the Theater Facilities Supervisor Position</u>

With the high volume of community contact, Trustee Almonte asked if the job was requiring that applicants be bilingual. John Thompson, Senior Director II, Human Resources, indicated that requiring an applicant to be bilingual was not typical and that he would not recommend limiting the candidate pool; however, he did suggested adding "bilingual preferred" to the job description.

In addition, responding to Trustee Sullivan's concern regarding continued in-service training to keep up on the most current upgrades, staff indicated that the District currently has a comprehensive training and that additional training would be provided as needed.

Trustees James would like to add the following wording under <u>Licenses and Other Requirements</u>: "Must be able to physically access all areas of the theater and back of house including the catwalk and be comfortable working on and climbing ladders and working at heights."

Following the suggestions, it was the consensus of the Board to include "Bilingual preferred" and Trustee James' added wording to the job description.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee Prola, the Board approved the job description of the Theater Supervisor and Position with the added modifications by a 7-0 vote.

1.1-CF 2011 CSBA Delegate Assembly Election

The Board discussed and considered the submission of a ballot for the 2011 CSBA Delegate Assembly.

Following the tallying of the written votes the Board submitted the ballot, casting a vote for David Haubert (Dublin USD); Lily Mei (Fremont USD); Diana Prola (San Leandro USD); and Nancy Thomas (Newark USD).

Facilities & Construction

5.1-CF Selection of Architect Firms for Professional Design Support for November 2010 General Obligation Bond

The Board discussed and considered the recommended Measure "M" architect pool to complete the projects designated in the November 2010 Facility General Obligation Bond Election.

Assistant Superintendent Song-Chin-Bendib explained that from the forty (40) outstanding proposals received, District staff interviewed eleven (11) qualified architectural firms. The selected architects qualifications and portfolios were reviewed including rigorous background checks. Of the eleven (11) firms interviewed, the following six (6) firms were selected for the Measure M architectural service pool:

- AEDIS Architecture & Planning
- Deems Lewis McKinley (DLM) Architecture
- Jeffrey E. Wong Architects
- SIM Architects, Inc.
- Spencer Associates Architects & Planners
- WLC Architects, Inc.

Following approval the selected firms, staff will be bringing the list of assignments for specific projects to the March 15 Board meeting.

It was also noted that now that the architectural pool has been selected, the District may then contract and negotiate for any of the Measure M bond projects. In addition it was explained that Superintendent Cathey, Assistant Superintendent Song Chin-

Bendib, Director of Measure B Mike Murphy and Harris & Associates Construction Program Director Kurt Weidmann narrowed the number of candidates to the recommended six and that the Board of Education is not part of the selection process.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee Almont, the Board approved the selected architect pool to complete the projects designated in the November 2010 Facility General Obligation Bond election by a 7-0 vote.

ADDITIONAL SUGGESTIONS AND COMMENTS FROM BOARD MEMBERS

• Trustee Prola reported attending the Keep the Music Rockin' Foundation meeting with Sheila E.

She reminded the Board that the California Conservatory Theatre of San Leandro is having their annual fundraiser "Finger Lickin' Chicken Dinner" featuring singers, dancers and actors in the Bay Area, on Sunday March 6, catered by Strizzies. Tickets are \$25.

The Democratic Central Committee will be hosting a St. Patrick's Day dinner on March 17. Key speakers include State Superintendent of Public Education Tom Torlekson and State Treasure Bill Lockyear. Tickets are \$25.

She commented that to-date thirty-eight (38) school districts have adopted a resolution in support of placing a revenue extension measure on the ballot. She suggested that Board members visit school PTAs and Dads' Clubs and stress the importance of supporting this measure to protect our schools and students by making education a priority in our state. Trustee Mack-Rose added that the Advocacy Committee will be discussing this.

- Trustee Carey commented that Friday, March 4, is Madison Elementary School's fundraiser at Drakes.
- Trustee Katz-Lacabe commented that SLED Eat Out for Education is March 2; and the San Leandro High School Baseball Team Pancake Breakfast fundraiser is Saturday, March 5.

He also noted the passing of former San Leandro City Councilmember Faith Frazier, who was deeply committed to supporting women and equal rights in City government.

• Trustee James commented that he attended the Black Students Union Talent Show fundraiser at Bancroft Middle School on February 18. He also attended the 9th grade orientation at the Fred T. Korematsu campus.

• Trustee Sullivan commented that she will be attending the March 3 Latino Achievement Night at Bancroft Middle School.

She commented on an email sent from Bobbie Brooks, Southern Alameda County Alliance of African-American Educators, stating that one San Leandro High School student was recognized in 2009 and seven students in 2010. Trustee Sullivan encouraged counselors to submit the names of more African American students.

• Trustee Mack-Rose was pleased that the City is planning on funding a portion of the crossing guards; however, she firmly believes that pedestrian street safety is the responsibility of the City, and hoped that in the future the City would agree to fund the entire program.

She asked for consensus directing the Policy Committee to look at developing a policy regarding facilities sponsorships i.e. signage and sponsorship opportunities. (Consensus received)

She will participating in "Read Across America" tomorrow, March 2; and will be dining at Mama Lupe's Restaurant in support of Eat Out for Education that evening.

Superintendent Cathey announced the passing of former District employee Sandi Smith, who taught at the San Leandro Adult School and was vice principal at Bancroft Junior High School (Bancroft Middle School), bringing to mind her endless energy, the biggest smile and the biggest heart for doing good work and believing in the students. Services will be held on March 6. She asked that the meeting be adjourned in her honor and memory.
