SPECIAL MEETING OF THE BOARD OF EDUCATION - MINUTES

March 8, 2011

The Board of Education of the San Leandro Unified School District met in special session on March 8, 2011, in the San Leandro Unified School District Office Conference Room 1, 14735 Juniper Street, San Leandro, California.

The meeting was called to order at 6:06 p.m. by President Mack-Rose.

PUBLIC COMMENTS

There were no public comments concerning items on the closed session agenda.

CLOSED SESSION

At 6:07 p.m., the Board went into Closed Session for Student Expulsions, Public Employee Performance Evaluation, Title: Superintendent's Evaluation; Public Employee Discipline/Dismissal/Release/Hiring; Conference with Labor Negotiator, Public Employee Appointment – Title: Director of Business Services pursuant to Educational Code Sections 35146 and 48918(c), and Government Code Sections 54957, and 54957.6.

The Board returned to open session at 7:09 p.m. with the Pledge of Allegiance to the Flag. President Mack-Rose noted that the Board had been in closed session where the following action was taken:

- On a motion made by Trustee Katz-Lacabe and seconded by Trustee Carey, the Board took action in closed session to non-reelect probationary certificated employees pursuant to Education Code section 44929.21 by adoption of Resolution #11-14. This resolution was approved by a roll call vote of 6-0. Trustee Sullivan was absent.
- On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board took action in closed session to release and reassign administrative certificated employees pursuant to Education Code section 44951 by adoption of Resolution #11-15. This resolution was approved by a roll call vote of 6-0. Trustee Sullivan was absent.
- On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board took action in closed session to non-reelect probationary certificated employees pursuant to Education Code sections 44951 and 44929.21 by adoption of Resolution #11-16. This resolution was approved by a roll call vote of 6-0. Trustee Sullivan was absent.

President Mack-Rose stated that a comment card received after closed session referenced a closed session item. She asked that the agenda be amended to give the person and opportunity to address the Board.

On a motion made by Trustee Prola and seconded by Trustee Katz-Lacabe, the Board approved the agenda as amended by a 6-0 vote. Trustee Sullivan was absent.

• Louise Shaw, District teacher, addressed the Board regarding two non-reelected teachers at Wilson Elementary School. Conveying several areas shared to her by the teachers, they felt adequate feedback regarding their performance was not given to them that would warrant their non-reelection, Ms. Shaw felt that was a flaw in the system and urged the Board to reconsider offering these teachers another probationary year.

BOARD MEMBER COMMENTS

• Trustee Carey commented on the success of the Latino Student Achievement Night, noting that it was great to see the support shown to the students.

He also attended the fundraiser for Madison Elementary School at Drakes on Friday, March 4.

• Trustee Katz-Lacabe offered kudos to staff for making the Latino Student Achievement Night such a huge success.

He also attended the San Leandro High School Pirate Talent Show and the San Leandro High School Baseball Team Pancake breakfast fundraiser.

He reported that Superintendent Cathey and he attended the budget briefing, hosted by Senator Corbett and State Treasurer Lockyer, focusing on California's serious fiscal challenges.

Trustee Katz-Lacabe encouraged the Board to visit Zocolo's Coffee House, where Bancroft Middle School student artwork is displayed and the San Leandro Main Library, where elementary school student artwork is displayed. Both exhibits can be viewed for the entire month of March.

• Trustee James commented on the tax extension measure and the urgency for the Board to reach out to the community, and send emails to the legislators in support of placing this measure on the June ballot.

He is looking forward to attending the San Leandro High School Crab Feed.

- Trustee Almonte attended the Latino Student Achievement Night. He thanked Deborah Cox and Jeni Engler for their dedication and leadership with regards to the Arts Education Center.
- Trustee Prola commented on the Latino Student Achievement Night, adding that the recent census report showed that the Latino population has grown to be the second largest group in San Leandro. She also offered kudos to Superintendent Cathey for giving a portion of her remarks at that event in Spanish.

She also attended the San Leandro High School Baseball Team Pancake Breakfast.

Piggybacking on Trustee James comments, she said that she had the opportunity to briefly speak with Senator Corbett who stressed the

importance of contacting representatives sooner rather than later regarding the tax extension ballot measure.

• Trustee Mack-Rose commented that she attended State Superintendent Torlakson's event, and unfortunately felt that it was not very fruitful in that there was no sense of urgency conveyed to get the tax extension on the ballot, and for the most part the majority of the questions focused on nonbudgetary issues such as parent involvement and technology.

She commented that at the pancake breakfast, the meal was served on polystyrene plates, utensils and cups which are purchased by the group hosting the event. She asked for consensus to have the Policy committee consider banning polystyrene dinnerware in the District. (Consensus received)

Trustee Mack-Rose suggested that now that the census data has been published, she would like to see the District to revisit decreasing the number of Board trustees from seven to five. It was the consensus of the Board to direct staff to begin exploring the process to go from seven trustees to five.

She commented that she visited three school sites during "Read Across America Day." She also had the opportunity to speak with Alex Harp, Lincoln High School principal, regarding alternative education.

At 8:02 the Board returned to closed session for Superintendent's Evaluation and reconvened to open session at 8:30 p.m. where President Mack Rose reported that no action was taken.

ADJOURNMENT

On a motion made by Trustee Katz-Lacabe and seconded by Trustee Carey, the Board adjourned the meeting at 8:30 p.m. by a 7-0 vote.
