REGULAR MEETING OF THE BOARD OF EDUCATION - MINUTES

April 19, 2011

PUBLIC COMMENTS REGARDING CLOSED SESSION AGENDA

There were no public comments concerning items on the closed session agenda.

CLOSED SESSION

At 6:00 p.m., the Board went into closed session for Student Expulsions, Public Employee Discipline/Dismissal/Release/Hiring, Conference with Labor Negotiator, Conference with Legal Counsel – Anticipated Litigation – Significant exposure to litigation – 1 case, and Public Employee Appointment – Title: Theatre Facilities Supervisor, and Vice Principal, John Muir Middle School pursuant to

Education Code Sections 35146 and 48918 (c), and Government Code Sections 54957, 54957.6, and 54956.9. The closed session was adjourned at 7:00 p.m.

The Board returned to open session at 7:06 p.m. with the Pledge of Allegiance to the Flag. President Mack-Rose said the Board had been in closed session where the following action was taken:

- On a motion by Trustee Katz-Lacabe and seconded by Trustee Sullivan, the Board appointed Dustin Brown as the Theatre Facilities Supervisor, by a 7-0 vote.
- On a motion made by Trustee Prola and seconded by Trustee James, the Board appointed Zachary Kahn to a short term/temporary administrative assignment as a Vice Principal of John Muir Middle School by a 7-0 vote.

APPROVAL OF AGENDA

On a motion made by Trustee Katz-Lacabe and seconded by Trustee Prola, the Board approved the agenda for the regular meeting of April 19, 2011, by a 7-0 vote.

REPORT

Recreation & Parks Commission Report: Juan Manuel Martinez, San Leandro Unified School District Representative updated the Board on activities of the Recreation & Parks Commission. Highlights included:

- The 2011 park season began April 1, 2011, and goes through October 30, 2011
- The grand opening for the Senior Community Center was April 2
- Funds have been received for the memorial for Luster Knight who was a Recreation & Parks Commissioner and Alameda County Firefighter.
- New park assignments have been assigned. In addition to overseeing the school parks, he will be reporting on Grover Cleveland and Halcyon parks
- This month he has been seeking business participation in the upcoming Cinco de Mayo celebration

PUBLIC TESTIMONY ON NON-AGENDA ITEMS

• Chris Crow addressed the Board regarding the design for Burrell Field and Measure M and in support of the football team. As a member of the design committee, he stated that he felt ideas shared by the 50 people in

attendance such as removing the track from the Burrell field design and building one track at the high school giving San Leandro an opportunity to create the best field sports stadium in a 50-mile radius were not considered. He urged the Board to make a different decision for Burrell and "give the football team and soccer team the true field sports complex that they really deserve."

- Adan Alonzo reminded the Board of the request he made at the April 5 Board meeting requesting an explanation regarding the decision made to non-reelect the Assistant Principal at San Leandro High School, stating that "Parents, students, and teachers need an answer." Following his comments President Mack-Rose reminded him that this was a personnel issue and the Board cannot respond; however, Senior Director II of Human Resources John Thompson may be able to provide further clarification.
- Stacy Kaplan addressed the Board in support of keeping the middle school counseling program, citing that middle school counselors are not a luxury, they are a necessity and this program helps thousands of students.
 Counselors not only counsel, they teach students study skills, work ethnics and how to be better friends, citizens, and sons and daughters. She urged the Board to rescind the cuts to middle school counselors.

PRESENTATIONS

* John Muir Advancement Via Individual Determination (AVID) Program
Update

John Muir Middle School recently was re-validated for another two years as an AVID National Demonstration School. Belen Magers, Principal, and Stacy Kaplan, AVID Coordinator and AVID Teacher provided information on the school's AVID program and shared highlights, including testimonials from students. Highlights included:

- John Muir Middle School is one of only 2% nationwide National AVID (Advancement Via Individual Determination) Demonstration Schools, and the only middle school in Region 4 (north of San Jose) recognized as a national demonstration school
- As an AVID school and demonstration school they have and are promoting the college-going culture among the students and parents including a 9-week Saturday Academy course offered in the fall and spring for academically at-risk students

- Incoming 6th grade students are invited to apply in April-May based on CST > 300, GPA 2.0-3.5, teacher recommendation, sibling already in AVID
- Tutors include San Leandro High School graduates, regional AVID graduates, CSU East Bay and Chabot College students, and EnCorps teachers in training
- 2009-2010 AVID elective composition breakdown showed that out of 111 students 27% were Title 1, 31% RFEP, 3% ELL, 17% IFEP, and 51% bilingual
- A sample week in the AVID elective includes tutorials, binder and note checks, career & college information, field trips, motivational speakers and team building activities
- In addition AVID students take notes during all four academic classes and can expect 2 hours of homework Monday-Thursday
- Sixty-five percent (65%) of the current 8th grade AVID students improved by over 5% on the ELA-CSTs and 26% improved by 10% or more

Students in the AVID program were present and shared how AVID has benefited them. Comments included "Cornell Notes has helped me to be more organized and review for tests"; "AVID has helped me improve my study skills"; "Tutorials have furthered my understanding of what is being presented"; "Collaborating with your peers helps you when you are stuck on something"; and "Going on field trips to college campuses helped me experience life on a college campus."

Following the presentation Trustees Carey and Sullivan shared how his son and her daughter respectively were AVID students and how it prepared them for college and improved their writing skills.

Additional comments and questions from the Board included when the program began in the District, how many San Leandro AVID students have graduated from college, and integrating art, and music into the AVID life.

The Board thanked the presenters and offered kudos to the students for sharing their experiences.

* Academic Tiered Intervention System Update

Debbie Wong, Interim Assistant Superintendent of Educational Services and Mike Walbridge, Director of Curriculum and Instruction, provided information related to the District's first year implementation of the Academic Tiered Intervention System. The presentation included a review of our pyramid of interventions, elementary *Reading Academy*, and secondary Companion courses, including student achievement results. The Summer School Program description was also provided. Included in the presentation were lessons learned and next steps for year two implementation. Highlights included:

- 2010-11 the focus has been on implementing a strong English Language Arts core instruction
- 2011-12 the focus will be on mathematics, while continuing to support the ELA system

PUBLIC COMMENT

• Jennifer Engler, Roosevelt Elementary School teacher, spoke about the DRA (K-3 reading assessment) and how valuable it is and how much she relies on it to provide important information, suggesting that the District revisit the new Diebels testing system and how the information is reported on the report card. She also would like to see an informal survey of all educators where they can jot down pros, cons, what they think has worked and what can be improved upon.

Comments and questions raised by the Board included:

- Criteria used to determine that Tiered Intervention has been successful and how long do we continue down this path before we make a determination regarding if it is successful or not
- The cost for students to attend the summer music program
- Specific examples of secondary Tier I benchmark assessments for assessing students
- Concerns should a student not exit the Companion class
- Chart the ways the sites are approaching grades 4 and 5
- Is the District considering a Math Academy for next year?

The Board thanked staff for the very thorough and informative presentation.

- 2) Student Board Member Report Jeff Engler, Student Board Member provided the Board with an update on activities at the San Leandro High School main campus and the Fred T. Korematsu Campus. Highlights included:
 - Elections for the 2011-12 school year have begun. The Associate Student Body officer election is this week. On Monday, April 18, the candidates gave speeches and students will be voting this week; Class officers election will be in the upcoming weeks
 - Next week is STAR testing with San Leandro High School setting a loftier goal of 800 (last year scores improved over 700). If incentives are met, rewards may include a carnival or early out day in the fall
 - Spring Musical, "Once Upon a Mattress" opens on Thursday, April 28, 7:00 p.m. and will be performed at the new Arts Education Center. Additional performances will be on April 29, 30, May 5, 6, 7 with a 1:00 p.m. matinee performance on Sunday, May 1

3) Union Representative Reports

- Mark Hamilton, on behalf of the San Leandro Teachers' Association, thanked Superintendent Cathey, Trustee Prola, and Senior Director II John Thompson for their support of the informational picketing at San Leandro High School today. Upcoming events include an afterschool rally at San Leandro High School on May 3, and CTA sponsored events the following week. Mr. Hamilton commented on tonight's John Muir AVID program and the Academic Tiered Intervention System Update presentations, and echoed the sentiments expressed earlier regarding the value of counselors, and urged the Board to preserve counseling in the District.
- 4) Superintendent Report Superintendent Cathey provided the following report:
 - Thursday, April 14, she took a tour of the Sheet Metal Workers Local #104 training facility, which supports training for all of Alameda and Contra Costa Counties. She toured the entire training facility, which was very impressive, and talked about career paths and ideas of how the district can partner with them to reach out to our students.
 - Friday, April 15, Interim Assistant Superintendent Debbie Wong and she attended an orientation from Kaiser related to a grant received to support Wilson Elementary School Playworks program and Cyberbulling student assemblies and staff training at Bancroft and Muir Middle Schools.
 - The District received a collaborative planning grant from the San Francisco Foundation for community schools.
 - Through Supervisor Wilma Chan, the District received a \$125,000 grant to focus on wellness and health.
 - On April 15, Assistant Superintendent Song Chin-Bendib, representative's from KNN and she presented the District to Moody's Investor Services. A variety of topics were discussed including an overview of the District, the growing partnership with the Chamber and local businesses, support of the City, fiscal state of the District, and the professionalism and strength of the Board as they have faced drastic budget cuts. They also met with Standards & Poor's. We should be receiving our rating from both agencies by April 29.

Senior Director II John Thompson explained that after extensive review it was determined that the Associate Principal position at the FTK campus has duties and tasks that are unique to this campus and beyond the scope of the high school Assistant Principal position. The job description has been revised to delineate the duties and job requirements of this position.

Responding to questions raised by Trustee Prola and Trustee Sullivan regarding posting the job before the job description was approved and whether or not applicants who already applied were aware of the revisions, it was explained that those who have applied are interested in various administrative positions being offered in the District, so typically if the candidate makes it to Level II in the interview process, there is an in depth and meaningful discussion on the expectations of the position at that time.

On a motion made by Trustee Katz-Lacabe, and seconded by Trustee James, the Board approved the Fred T. Korematsu Associate Principal Job Description by a 7-0 vote.

Responding to Trustee Prola's inquiry if there was a "local agreement clause" added to the agreement, Assistant Superintendent Song Chin-Bendib explained that normally such a clause is not in the PSA agreement and after consulting with legal counsel, they do not recommend adding such a clause because of the "Fair Labor Act" that prevents us from specifically stating that we want "local hire." However, when asked if possibly considering adding "local hire is preferred," the Assistant Superintendent said that she could check with legal counsel.

On a motion made by Trustee Prola and seconded by Trustee James the Board approved the Project Stabilization Agreement (PSA) Amendment No. 1 for the San Leandro Unified School District Measure B New Construction and Modernization Project which incorporates Measure M bond projects into the PSA, by a 7-0 vote.
