#### REGULAR MEETING OF THE BOARD OF EDUCATION - MINUTES

July 19, 2011

The Board of Education of the San Leandro Unified School District met in regular session on July 19, 2011, in the San Leandro City Council Chambers, 835 East 14th Street, San Leandro, California.

The meeting was called to order at 6:00 p.m. by President Mack-Rose.

#### PUBLIC COMMENTS REGARDING CLOSED SESSION AGENDA

There were no public comments concerning items on the closed session agenda.

#### **CLOSED SESSION**

At 6:01 p.m., the Board went into closed session for Public Employee Discipline/Dismissal/Release/Hiring; Conference with Labor Negotiator: CSEA and Unrepresented Employees: SLMA; Superintendent; Conference with Legal Counsel – Anticipated Litigation – Significant exposure to litigation – 1 case pursuant to Government Code Sections 54957, 54957.6, and 54956.9(b). The closed session was adjourned at 7:00 p.m.

The Board returned to open session at 7:07 p.m. with the Pledge of Allegiance to the Flag. President Mack-Rose said the Board had been in closed session where the following action was taken:

 On a motion made by Trustee James and seconded by Trustee Prola, the Governing Board voted to affirm the Superintendent's decision to dismiss a maintenance worker who was the subject of the June 8 appeal, a permanent classified employee, from the District's classified service and to adopt the Governing Board's written Opinion and Decision.

The vote was 5-1-1 with Trustees Almonte, Carey, James, Mack-Rose, Prola voting in favor of the motion, Trustee Sullivan voting against it, and Trustee Katz-Lacabe absent. The Governing Board also directed the Superintendent to personally deliver a copy of the Governing Board's Opinion and Decision to the parties or representative this evening, if possible, and to mail same to the parties tomorrow. The Governing Board's findings and decision on this matter are final.

#### APPROVAL OF AGENDA

On a motion made by Trustee Sullivan and seconded by Trustee Katz-Lacabe, the Board approved the agenda with the addition of the City Disaster Preparedness Report for the regular meeting of July 19, 2011, by a 7-0 vote.

The Superintendent and Board of Education recognized members of the Measure M Sports Complex and Burrell Field and the San Leandro High School Swim Center Conceptual Design Teams with a Certificate of Commendation.

\* Bond Projects Presentation

Song Chin-Bendib, Assistant Superintendent Business and Operations and Mike Murphy, Director of Bond & Measure B Projects, provided a presentation on the bond projects. The presentation included three major parts with the main goal to have the Board identify, discuss and approve the projects to be funded from the Measure B savings.

The three parts of the presentation were:

- 1. A progress and annual report on the Measure B bond projects. The report included up-to-date expenditures, estimated percentage of projects completed, state matching fund savings and other relevant information related to the Measure B bond
- 2. An update on Measure M including the completed Conceptual Design meetings and preparation for the next steps
- 3. Identification of projects to be funded from Measure B savings. These are projects above and beyond those funded from the regular \$109M Measure B Bond. As of June 30, 2011, Measure B Bond has savings from State Matching Funds in the amount of approximately \$17M. The Board identified projects to be funded from the savings.

Following some clarifying questions, the Board thanked staff, the Oversight Committee for all of their work completing projects on time and under budget.

# 5.1-CF <u>Discuss, Consider and Approve the Proposed List of Projects to be</u> Funded from Measure B Savings

The Board discussed and considered approving the proposed list of projects to be created and funded from Measure B savings.

Assistant Superintendent Song Chin-Bendib walked the Board through the list of proposed additional projects to be funded from Measure B savings. The list summarized those projects that have been approved and completed through the Financial Reserve, projects recommended this evening for consideration and approval, and additional projects for consideration in the event of additional savings. The list totaled approximately \$27M.

Following a discussion, the Board agreed that because of their lack of skill and familiarity of the needs at all of the District facilities, they would start with the staff recommendations.

It was the consensus of the Board to approve priority items #7-13 as recommended by staff and proceed with ranking the remaining priority items #14-25.

Looking at priority items #14-25, the Board suggested that items #24 and #25 (installation of security camera systems at the two

middle schools) be combined, bringing the number of items to be ranked to eleven.

Each of the Board members read their ranking numbers which were recorded. Staff will tally the numbers and bring the results back to the Board at the next meeting on August 2.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board approved the priority items #7-13 additional Measure B projects/scopes as recommended by staff to be created and funded from Measure B savings by a 7-0 vote:

#### 4) **Board Committee Reports**

- Communication Trustee Katz-Lacabe reported that the Committee met on June 24 and discussed the end of year community communications from the Superintendent, Measure B summary article, On-Line Board agenda, and next steps for the Website.
- Curriculum- Trustee Sullivan reported that the committee met on June 22, and discussed Grade 4-5 Strategic Tiered Intervention (Reading Academy) Supplemental Adoption - Teacher Created Materials: Targeted Intervention; and Middle School ELD Adoption -Pearson Longman: Keystone, Keys to Learning, and Building Bridges, which were adopted by the Board at the June 28 special Board meeting.

- Policy Trustee Sullivan reported that the committee met on June 22, 2011, following the Curriculum meeting and discussed Revisions to Board Administrative Regulation 6153, and Exhibit E(4a) 6153 School-Sponsored Trips which is being brought forward for consideration tonight. Additionally the committee discussed Board Policy and Administrative Regulation 1325 Advertising and Promotion.

  that emergency contact numbers can be entered, which links to the
  system to receive emergency updates.

Carol Delton, on behalf of the San Leandro Teachers'
 Association, addressed the Board regarding the phrasing of item #9 "No specific percentage was negotiated for salary increases"..., noting that it would be more accurate to remove the word "specific" from the phrase.

On a motion made by Trustee Prola and seconded by Trustee Carey, the Board approved the Public Disclosure of Collective Bargaining Agreement by a 7-0 vote.

5.1-C Proposal from Hohbach-Lewin, Inc. to Provide a District Wide Seismic Evaluation of Buildings (Mack-Rose)

Staff noted that the amount of the proposed contract should read "Not to exceed \$66,500" as noted in the contract rather than 7/19/11 - PAGE 9

\$65,000 as printed on the agenda.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board approved the Proposal from Hohbach-Lewin, Inc. to Provide a District Wide Seismic Evaluation of Buildings, as amended, by a 7-0 vote.

# 5.3-C Agreement with Vista Environmental Consulting, Inc. for Hazardous Materials Assessment, Testing, and Monitoring for Measure M Projects

Trustee Carey asked for clarification regarding item numbers 1a and 2a under "Hazardous Materials Assessments" on the contract, limiting the number of asbestos assessments to two samples.

Mike Murphy, Director of Measure B, said that these were "not to exceed figures"; however, he would get further information from the firm on the reason for limiting the number of samples.

On a motion made by Trustee Carey and seconded by Trustee Katz-Lacabe, the Board approved the Agreement with Vista Environmental Consulting, Inc for Hazardous Materials Assessment, Testing, and Monitoring for Measure M Projects, with the noted clarification request, by a 7-0 vote.

# 4.1-A Resolution #11-37 Temporary Borrowing between Funds for Fiscal Year 2011-2012

Assistant Superintendent Song Chin-Bendib explained that routinely every year, the state is continuing to defer its "deferred payments" in 2011-2012, causing districts like ours to receive only 75% of cash in relation to its apportionment or entitlements. While the District has been managing its cash reserve very well, as a precautionary step, staff is recommending that in the event of a cash shortfall, the Board pass a resolution allowing a temporary borrowing of up to \$5,000,000.00.

On a motion made by Trustee Prola and seconded by Trustee Sullivan, the Board adopted Resolution #11-37 Temporary Borrowing between Funds for Fiscal Year 2011-2012 by a 7-0 vote.

4.1-CF <u>Contracted Services Agreement Procedures for Amounts of \$5,000 or Less</u>

#### PUBLIC COMMENT

• Carol Delton, on behalf of the San Leandro Teachers' Association, addressed streamlining the contracted services agreement procedures, offering three suggestions: (1) Hourly rate should always been included with the information; (2) contracts are for a maximum of \$5,000 for a fiscal year; and (3) the individual name associated with company be included.

The Board agreed with Ms. Delton's suggestions so that the information is clear and transparent. In addition, it was suggested that the hourly rate should match the scope of expertise to ensure the District is providing the best service for our youth, the word "program" be included with the description, and that contracts should come before the Board for consideration before services are rendered.

It was the consensus of the Board to have staff provide further clarification and bring it back to the August 2 Board meeting for Board consideration.

# ADDITIONAL SUGGESTIONS AND COMMENTS FROM BOARD MEMBERS

Trustee Prola distributed a copy of a brochure from the California
Conservatory Theatre of San Leandro listing the proposed performance
schedule for 2011-2012. She also noted that the theatre Board (of which
she is a member) is considering offering a children's theatre program in the
future.

Based on emails she has received from members of the CSBA Region VII State Delegation representing Alameda and Contra Costa Counties, it appears that many districts are not hiring counselors.

While attending the Kaiser "signing of the beam" ceremony, she learned about free programs offered such as Sexually Transmitted Diseases (STDs), and was told it would be a very appropriate program for the Fred T. Korematsu Campus students.

 Trustee Katz-Lacabe commented that he was disappointed that Victor Doan was not the recipient of the Comcast award.

He also offered kudos to the maintenance and custodial staff for their ongoing responsive work over the summer.

• Trustee James announced that he will miss both August Board meetings, as he will be out of the country.

He announced that July 22, Drakes Barrel Room Ribbon Cutting Ceremony; July 23, fundraiser benefiting the San Leandro Education Foundation (SLED) in the Barrel Room, and August 5, "First Friday's" fundraiser for SLED at Drakes.

- Trustee Sullivan commented on if any District staff attended the Emergency Preparedness Fair that was hosted by the Alameda County Health Department in May, and if staff members other than District nurses were CPR certified. Assistant Superintendent Wong said that the District offers CPR training to Special Ed. Para Educators and PE staff annually, and now some of the District's 7th graders have been trained.
- Trustee Almonte commented on the safety of the District schools. He asked for consensus for the Superintendent to provide more information related to student fights that have occurred on the high school campus, as well as a plan of action that can be implemented this coming year focusing on a proactive approach that will alleviate animosities among the students.

Following a brief discussion for clarification, it was the consensus of the Board to have the high school provide a presentation early this fall regarding their upcoming plans for 2011/12 implementation.

• Trustee Mack-Rose commented on the recent approval of a bill making California the first state in the nation to add lessons about gays and lesbians to social studies classes in public schools, adding that she is looking forward to seeing it in our schools.
