June 28, 2011

The Board of Education of the San Leandro Unified School District met in special session on June 28 2011, in the San Leandro City Council Chambers, 835 East 14th Street, San Leandro, California.

The meeting was called to order at 6:00 p.m. by President Mack-Rose.

PUBLIC COMMENTS REGARDING CLOSED SESSION AGENDA

There were no public comments concerning items on the closed session agenda.

CLOSED SESSION

At 6:00 p.m., the Board went into closed session for Conference with Labor Negotiator, Public Employee Performance Evaluation: Title: Superintendent's Evaluation pursuant to Government Code Sections 54957, and 54957.6. The closed session was adjourned at 7:00 p.m.

The Board returned to open session at 7:07 p.m. with the Pledge of Allegiance to the Flag. President Mack-Rose said the Board had been in closed session where the following action was taken:

• The Board approved the settlement agreement of the Administrative Hearing Case #2011060370 by a 7-0 vote.

PRESENTATIONS

- * Song Chin-Bendib, Assistant Superintendent for Business and Operations provided a presentation on the 2011-2012 Adoption Budget which includes Fiscal Years 2012-2013 and 2013-2014. Highlights included:
 - The 2011-2012 Adoption Budget which reflects a projected positive fund balance of \$4,242,043 in the Unrestricted General Fund, which includes all Tier III flexibility (swept and unswept)
 - The District continues to maintain the minimum 3% Reserve requirement in Fund 17, Special Reserve Fund for Other than Capital Outlay Projects
 - The District's pattern of Deficit Spending
 - Fiscal Year 2011-2012 (\$925,700)
 - Fiscal Year 2012-2013 (\$1,692,822)
 - Fiscal Year 2013-2014 (\$1,861,901)
 - The County will caution the District on its deficit spending, which should not affect the District receiving a positive certification as we do have a positive fund balance.
 - Budget Reductions Resume in Fiscal Year 2012-2013
 - K-3 class size goes to 32:1
 - Secondary class size is back to an average of 30:1
 - Middle school counselors are eliminated
 - Instructional music is reduced 50%
 - Lighthouse reduced by 1.0 FTE
 - Campus Supervisor reduced by 1.0 FTE
 - Vice Principal at Middle & Elementary reduced by 1.0 FTE

Charts were shared highlighting enrollment, assumptions, Unrestricted General Fund Revenue and Expenditures, Combined General Fund Revenue and Expenditures, Other Funds, and an Appendix chart, further clarifying questions, issues, and concerns such as the deficit spending raised by the Board.

PUBLIC HEARING

• An official public hearing was conducted regarding the SBX3-4 Categorical Tier III Flexibility Acceptance and Use of Funds for 2011-12.

The Budget trailer bill (SBX3-4) gives local school agencies the authority to use the funds received from the state for Tier III programs for "any education purpose, to the extent permitted by federal law". These local education agencies are allowed to transfer funds from categorical programs to the Unrestricted General Fund for any educational purposes. The original language in SBX 3-4 allows Tier III categorical flexibility from 2008-09 through 2012-13. However, on March 11, 2011, the Governor signed into law Senate Bill (SB) 70 extending all existing flexibility options by two additional years, thus Tier III categorical flexibility will be effective through 2014-15.

Education Code (E.C.) Section 42605(c) (2) indicates that as a condition of receiving these funds, the Governing Board shall conduct a public hearing and "shall take testimony from the public, discuss, and approve or disapprove the proposed use of funding" and make *explicit* for each of the Tier III items the purpose for which the funds will be used. Tier III – SB X3-4 (E.C. Section 42605(c) (2) authorizes complete flexibility in the use of funds appropriated in 39 budget act items. These budget act items equate to more than 39 programs. Subsequent ABX4 2 that was signed into law amended the SBX 3-4 to increase the number of programs to 42.

By conducting a public hearing on a regularly scheduled Board meeting, the District would have met the requirement under Budget Trailer Bill SBX 3-4. This Board meeting is called a Special Board meeting, but it was announced and included in the Board packet since the beginning of the fiscal year. Additionally, the meeting was published in the Daily Review on June 14, 2011. Therefore, the meeting has been properly noticed. The Board held the official public hearing regarding the SBX3-4 Categorical Tier III Flexibility Acceptance and Use of Funds for 2011-12.

On a motion made by Trustee Prola and seconded by Trustee Katz-Lacabe, the Board opened the public hearing regarding the SBX3-4 Categorical Tier III Flexibility Acceptance and Use of Funds for 2011-12, by a 7-0 vote.

No comments were received from the audience.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board closed the public hearing regarding the SBX3-4 Categorical Tier III Flexibility Acceptance and Use of Funds for 2011-12, by a 7-0 vote.

4.1-A SBX3-4 Categorical Tier III Flexibility Acceptance and use of Fund for 2011-2012

On a motion made by Trustee Prola and seconded by Trustee James, the Board approved the SBX3-4 Categorical Tier III Flexibility Acceptance and Use of Funds for 2011-12 for any explicit educational purpose in order to provide services and programs for students by a 7-0 vote.

PUBLIC HEARING

An official public hearing was conducted regarding the 2011-2012 Adoption Budget. This public hearing satisfies Education Code 42120-42129. The hearing provides the community the opportunity to address the Board regarding the 2011-2012 Adoption Budget.

The 2011-2012 Adoption Budget which includes fiscal years 2012-13 and 2013-14 is submitted to the Board of Education for review and approval. Included in this Adoption Budget is also the Estimated Actuals for Fiscal Year 2010-2011. Estimated actuals show the latest and up-to-date projections for the current year's budget since the 2010-2011 Second Interim Report.

Assembly Bills AB 1200 and AB 2756 state that a district the size of the San Leandro Unified must maintain a minimum of 3% Reserve requirement. The District continues to maintain the 3% minimum reserve requirement in Fund 17, Special Reserve Fund for Other Than Capital Outlay Projects.

On a motion made by Trustee James and seconded by Trustee Katz-Lacabe, the Board opened the public hearing regarding the 2011-2012 Adoption Budget, by a 7-0 vote.

No comments were received from the audience.

On a motion made by Trustee Katz-Lacabe and seconded by Trustee James, the Board closed the public hearing regarding the 2011-2012 Adoption Budget, by a 7-0 vote.

On a motion made by Trustee James and seconded by Trustee Prola, the Board approved the 2011-2012 Adoption Budget Which Includes Fiscal Years 2012-2013 and 2013-2014 by a 7-0 vote.

4.1-CF Governmental Accounting Standard Boards' (GASB) Pronouncement #54

The Board reviewed and discussed the GASB 54 information as presented.

Assistant Superintendent Chin-Bendib explained that this was a new pronouncement from GASB and normally would require the Board to adopt a resolution. However, because we have already been complying with all applicable accounting standards, and that GASB 54 is no different, the District's independent auditors have stated that it is not mandatory for the District to implement these changes and that no action would be needed from the Board.

Responding to a comment made by Trustee Katz-Lacabe with regards to future liabilities under GASB #45, Assistant Superintendent Chin-Bendib noted that staff would be bringing a contract for actuarial report services to the Board this year.

It was explained that a draft calendar had been sent to the principal 6/28/11 - PAGE 7

before school ended. Once approved, the calendar would be posted on the District's website. In addition, at the suggestion of Trustee Mack-Rose, a global email will be sent informing the parents.

On a motion made by Trustee James and seconded by Trustee Carey, the Board approved the 2011-2012 School Calendar and the San Leandro Teachers' Association Work Year Calendar by a 7-0 vote.

ADDITIONAL SUGGESTIONS AND COMMENTS FROM BOARD MEMBERS

- Trustee Carey commented that he, along with approximately 60-70 District students, parents, staff and community members, participated in the "Pride Parade". He thanked Superintendent Cathey and Assistant Superintendent Wong for attending.
- Trustee Katz-Lacabe noted that San Leandro Mayor Cassidy was also in attendance.
- Trustee James commented on the need for revenue in the schools and our city.
- Trustee Prola asked for and received consensus to have the Facilities/ Technology Committee begin developing a strategic facilities plan for each school site.
- Trustee Mack-Rose also commented on how proud she was of San Leandro Unified for having an entry in the San Francisco "Pride Parade".

Assistant Superintendent Wong, who spearheaded the effort with the Task Force and teachers, added that San Leandro Unified was the only "school district" represented and out of 230 contingents, the District was #33 in the parade. Pictures taken at the event will be placed on our website.

At 8:04 p.m. the Board adjourned into closed session and returned to open session at 9:20 p.m., where President Mack-Rose said that no action was taken.
